May 2007 - **Malin Burnham**, retired prominent San Diego business and civic leader; "San Diego's history and its unique challenges as a border city with a diverse commercial, government and international foundation".

April 2007 - **Jerry Sanders**, Mayor of the city of San Diego; "The challenges ahead in managing the city".

March 2007 - **General William A. Anders**, graduate of the Naval Academy, and lunar pilot on Apollo 8, the first mission out of our solar system; "President Kennedy's determination for the U.S. to reach the moon, as well as the determination of everyone involved to overcome numerous technical and operational setbacks to finally succeed and fulfill the nation's goals in manned space".

February 2007 - Marye Anne Fox, Chancellor, University of California San Diego, and world renowned physical organic chemist; "The history of UCSD beginning in 1903 as a marine science laboratory through its founding as a university in 1960 until now as one of the nation's leading scientific and technical schools with 24,000 undergraduate students and 4,000 graduate students".

January 2007 - **Vice Admiral Edward H. Martin**, a 1954 graduate of the U.S. Naval Academy; "Experiences as a prisoner of war nearly six years in the infamous "Hanoi Hilton" and five personal disciplines he imposed upon himself to get through the six year ordeal. They were: 1) faith in God, 2) faith in the U.S., 3) faith in family, 4) faith in fellow POW's, 5) live to prove these faiths".

November 2006 - **Sergeant Major Wayne R. Bell**, U. S. Marine Corps, who has served as a Sgt. Major for ten years and has completed 30 years in the Corps; "The U.S. involvement in Iraq and the difficulty of military leadership in Iraq, including the timing and cost of deployment, troop replacement, cooperation or lack of it from Iraqis, politics, culture and other facts of the engagement making victory there difficult to achieve;

October 2006 - **San Diego City Attorney Michael Aguirre**; "The problems in San Diego of compliance with federal law concerning water supplies as well as the city's pension management issues".

September 2006 - **Rear Admiral John P. McLaughlin**, C.E.O. of the USS Midway Museum; "The organization, and execution of the plan to convert the Midway into a museum - the most successful ship museum in the world".

August 2006 - **James C. Clark**, Director General of the Mexico Business Center; "Current immigration policies and how they affect business relationships between our countries".

June 2006 - **Dr. Richard Atkinson**, President Emeritus of the University of California; "The origin and history of the formation and growth of the nation's research universities and their contributions to the US economy".

May 2006 - **Dr. Brent Eastman**, MD, FACS, chief medical officer of the Scripps health complex comprising more than 10,000 employees; "Disaster preparedness - personal thoughts and web sites to assist in understanding, anticipating and responding to possible disasters".

April 2006 - **Captain John C. "Jack" Ensch, USN (Ret.)**, Vice President of Military Affairs for the San Diego Padres baseball club; "Padres' commitment to acknowledging the importance of the Navy's presence in San Diego, and initiatives taken to attract baseball fans from within Navy personnel".
